b. Recruitment of new members to fill 2 vacant seats plus KGB Planning Dept recommendation Richard confirmed that a new KGB Planning Commission representative will be appointed after that empty seat is filled. Anita noted that our two vacant positions are both community representatives. Amanda suggested sending a notice to the Tongass Historical Society and Historic Ketchikan board members. Anita will develop a notice and send out.

Agenda Item #8 Unfinished Business

a. Memorial acknowledgement for Ward Lake Internees at Bayview Cemetery

Amanda noted that she was looking for people with this expertise to follow up with. The National Park Service has the same 2010 list of internees as Judith McQuerry shared. John will follow up with John Autry. He also noted there are site surveys at Ward Lake. Amanda suggested comparing the list of names who were sent to the camp with names at gravesites. Kris shared that the USFS District Ranger has been approached by the tribes and there is an opportunity to partner once it's clarified what is being asked of the USFS. The USFS will do a consultation but in the meantime, it's fine to gather information. John agreed that the common goal is to get the graves marked. Kris mentioned the need for a memorial in a location where there is a caretaker to avoid vandalism.

b. SHPO grants

Anita noted that SHPO has not received their federal appropriation for the Historic Preservation Funds yet and thus has not signed the grant agreements.

Agenda Item #9 Commissioner Comments

Amanda confirmed that the dilapidated sign on the cannery belongs to the Ketchikan Visitors Bureau and was part of their Ketchikan Story Project. John expressed a need for the community's signage to be maintained. Anita shared that there has been much discussion among City departments for a comprehensive signage program that is maintained by the City. Commercial Passenger Vessel funds could be used once the economy recovers. Christa agreed, noting the many different types of signs. Deborah highlighted Ricardo Burquez's new mural at Rendezvous Day Services and the need for more murals in town and the opportunity to share history through art. Anita shared that there are ongoing discussions also about a long term public art maintenance plan.
